Unpaid invoices are also subject to a 1 1/2% interest charge per month or any part thereof, and storage fees. If applicable, all shipping charges are the responsibility of the buyer. As determined by ROA, all large, expensive, fragile or heavy items will be packed and shipped by professional shipping companies, therefore, bid accordingly. Invoices must be paid in full prior to

In the event that there are more phone bidders interested in a lot than there are available lines, we then qualify all bidders. You will be asked a range of what you are willing to spend and the top bidders then will be called for that lot. This is a rare occurrence, but could happen as late as the day of sale.
