COMPUTED AVERAGE POSITION FOR DUPLICATE SINGLE VECTOR GPS OBSERVATIONS DOES NOT EXCEED H 0.03'. GRID COORDINATE FOR GPS1 IS REFERENCED TO THE TENNESSEE STATE PLANE COORDINATE SYSTEM OF 1983, NAD83(2011) (EPOCH 2010 GEOID12B, COMBINED SCALE FACTOR OF 1.00008 APPLIED TO LOCATIONS OBSERVED FROM GPS1.

- 4. FIELD WORK FOR TRACT 1 & 2 OF THIS SURVEY WAS PERFORMED WITH A COMBINATION OF TOPCON DUAL FREQUENCY GPS EQUIPMENT AND A LEICA TS12 2" ROBOTIC TOTAL STATION. SIDE SHOTS WERE TAKEN WITH ROBOTIC TOTAL STATION FROM INTERVISIBLE GPS CONTROL POINTS TO BOUNDARY ASPECTS OF SURVEY. "RTK" GPS POSITIONAL DATA WAS OBSERVED ON/BETWEEN DATES OF 12-18-2019 TO 02-28-2020 TO LOCATE CONTROL POINTS USED FOR BOUNDARY LOCATIONS USING A TOPCON HIPERV RECIEVER AS ROVER AND A HIPERGO BASE STATION FIXED ON GPS1(FIXED ON-SITE POINT).

  DUPLICATE SINGLE VECTOR GPS OBSERVATIONS WERE MADE ON THE

  SAME POINT, COMPUTED AVERAGE POSITION DOES NOT EXCEED:H 0.03'.
- 5. FIELD WORK FOR ALL BOUNDARY ASPECTS OF TRACT 3 WAS OBTAINED WITH RTK POSITIONAL DATA ON 02-28-2020 BY THE SAME EQUIPMENT AND SETUP IN NOTE #2. SINGLE VECTOR RTK GPS OBSERVATIONS WERE TAKEN DIRECTLY ON FOUND CORNERS ON THE NORTH, WEST & SOUTHERLY LINES OF TRACT 3 AND THE MAXIMUM HRMS VALUES DOES NOT EXCEED H 0.01' AT 1-SIGMA.
