**Description:** Striking setting in rural Lancaster County. Solanco Farm, 78 +/- acres, near Quarryville, featuring a 43 x 115 bank barn (8 horse stalls, cattle pens with locking head gates, 2 large feed bins, 14x60 concrete silo), 14 x 28 three bay carriage shed, 12 x 24 dog facility (6 dog pens with concrete pad), 10 x 18 storage barn.

- **Tract #1:** 34 +/- acres with farm buildings. Two story farmhouse has 5 bedrooms, 1.5 baths, eat-in kitchen, dining room, family room, sewing room area, and mudroom/laundry. 2 porches and a balcony / deck facing South overlooking the farm. Daylight basement (26x38 with 10x17 bump out) has a 2nd kitchen and an active spring house in the basement. Additional building right included in this tract potentially allows the buyer to subdivide and build a new set of buildings on this tract. 12.5 +/- acres tillable, 16.5 +/- acres pasture, 5 +/- acres wooded. - **Tract #2:** 43.5 +/- acres of bare land. 37.25 +/- acres tillable and 6.25 wooded acres. Additional building right included in this tract potentially allows the buyer to build a new set of buildings on this tract. In Act 319 Clean & Green and is not in Ag Preservation. Eden Twp (23.9 acres) & Bart Twp. (10 acres) Taxes estimated \$546 annually
