- 4. On Wednesday at 12noon, the top bidders within ten percent (10%) of the highest bid will be invited to offer competing bids. Invitees will be contacted by Alderfer Auction by phone. The contact information on the sealed bid form will be used, unless otherwise stated by bidder.
- 5. The sale of the property is subject to confirmation by the Seller. The Seller will make the final decision by 4PM Wednesday, October 13, 2021. The Seller expressly reserves the right to withdraw the Real Estate from sale and to reject any and all bids.

There is a 6% buyer's premium added to the hammer price of the sealed bid.

Closing/Settlement on or before November 30, 2021.

#### **Bid Notification:**

All bids shall be irrevocable and subject to acceptance following the submission deadline. All persons submitting bids will be notified of the acceptance or rejection of the bid. Failure of bidder to receive notice shall not constitute acceptance of bid. The buyer and seller shall sign the purchase agreement by Thursday, October 14, 2021 by NOON. All unsuccessful bids and deposits will be returned within four (4) business days.

### **Broker Participation:**

Alderfer Auction will pay a 2% commission to a real estate brokerage securing the winning bidder. The two Percent (2%) is paid on the high bid (not the purchase price) submitted on the sealed bid form. Commission will be paid to a properly registered broker whose prospect purchases and closes on the property. Broker participation commission is only paid if the client closes the transaction and Alderfer Auction receives its commission.
